

DECREE

OF THE RELEGATION OF

SEVEN DOLORS CHURCH, WYNDMOOR, PENNSYLVANIA

TO PROFANE BUT NOT SORDID USE

Seven Dolors Church, Wyndmoor, Pennsylvania has served as a worship site of Saint Genevieve Parish, Flourtown since 2003. The church, however, is no longer needed by the parish and the parish lacks the funding necessary to repair and maintain Seven Dolors Church without impeding the ministry of the parish. Consideration, therefore, must be given as to whether sufficient grave causes exist for the relegation of Seven Dolors Church to profane but not sordid use.

The following grave causes suggest that the church be so relegated and no longer be used for divine worship:

- 1) Seven Dolors Church is no longer needed by Saint Genevieve Parish. Seven Dolors Church is approximately one and a half miles from Saint Genevieve Church, so it is not a great burden for the faithful to come to the parish church to worship;
- Saint Genevieve Parish has endeavored to keep Seven Dolors Church in good repair. The parish, however, does not have the resources to continue to repair and to maintain the church without negatively impacting the ministries of the parish. In addition to operating costs, the cost of necessary repairs for the church is an estimated \$232,800;
- 3) there is no other source of funding and the financial burden of repairing and maintaining the church would cause important pastoral programs of Saint Genevieve Parish, such as its support of Catholic education, to suffer within the next few years due to lack of funds;
- 4) the church building does not have any particular architectural, historical, or artistic significance; and,
- 5) having all of the parishioners worship at the parish church will enhance parish unity.

Accordingly, in virtue of the prescripts of canon 1212 and canon 1222, §2 of the <u>Code of Canon Law</u>, having judged that sufficient grave causes are present and that the good of souls will not thereby be impaired and having consulted with the Council of Priests on December 13, 2013, I hereby **DECREE** that Seven Dolors Church, Wyndmoor, Pennsylvania, be relegated to profane but not sordid use.

This decree is effective as of July 1, 2014, and is to be communicated to the members of Saint Genevieve Parish and to the faithful of the Archdiocese in an appropriate manner. All things to the contrary notwithstanding.

DECREE

OF THE RELEGATION OF

ALL SAINTS CHURCH, PHILADELPHIA, PENNSYLVANIA

TO PROFANE BUT NOT SORDID USE

Due to the deteriorating condition of All Saints Church, Philadelphia and a lack of the funding necessary to repair and maintain the church, consideration must be given as to whether sufficient grave causes exist for the relegation of All Saints Church to profane but not sordid use.

The following grave causes suggest that the church be so relegated and no longer be used for divine worship:

- All Saints Church has been examined by experts who have determined that the building is in need of considerable repairs. Most notably the use of the church had to be suspended for safety reasons in October 2013 when inspectors found serious structural problems with the facade and the roof of the church. It is estimated that the cost of necessary repairs would be nearly one million dollars. This includes \$15,000 just for immediate stabilization and \$325,000 for repointing the stonework on the exterior of the church. The other buildings owned by the parish on the property with All Saints Church are in need of an additional one million dollars in repairs;
- 2) Saint John Cantius Parish, Philadelphia, which has ownership of All Saints Church, does not have the resources to repair and maintain the All Saints Church building. The parish has a debt of slightly over two million dollars and has difficulty in meeting operating expenses;
- 3) there is no other source of funding for the necessary repairs;
- 4) the financial burden of repairing and maintaining the church would cause important pastoral programs of Saint John Cantius Parish, such as outreach to the poor and educational efforts, to suffer due to lack of funds;

- 5) the church building does not have any particular architectural, historical, or artistic significance; and,
- 6) the people who had been attending All Saints Church are in reasonably close proximity to Saint John Cantius Church.

Accordingly, in virtue of the prescripts of canon 1212 and canon 1222, §2 of the <u>Code of Canon Law</u>, having judged that sufficient grave causes are present and that the good of souls will not thereby be impaired, having consulted with the Pastor of Saint John Cantius Parish, and having consulted with the Council of Priests, I hereby **DECREE** that All Saints Church, Philadelphia, Pennsylvania, be relegated to profane but not sordid use.

This decree is effective as of February 28, 2014, and is to be communicated to the members of Saint John Cantius Parish and to the faithful of the Archdiocese in an appropriate manner. All things to the contrary notwithstanding.

WITH

SAINT MARK PARISH, BRISTOL, PENNSYLVANIA

Saint Ann Parish, Bristol, Pennsylvania was founded in 1906 to serve Italian speaking people in the area. Saint Mark Parish, Bristol, Pennsylvania was founded in 1844. As the result of an Archdiocesan Pastoral Planning initiative, a proposal to merge Saint Ann Parish into the neighboring Saint Mark Parish was studied and discussed with committees from both of the parishes and with the appropriate archdiocesan offices. Throughout this process, sufficient information regarding the proposal was gathered, and consultation was conducted with members of Saint Ann Parish and Saint Mark Parish.

The following just causes suggest that Saint Ann Parish be merged into Saint Mark Parish:

- to provide more effectively for the pastoral needs of the faithful of Saint Ann Parish which has declined in population in recent years and no longer serves a predominately Italian speaking community;
- 2) to enhance evangelization efforts and to improve the vitality of parish life for the people of Saint Ann and Saint Mark Parishes;
- to address financial difficulties and to provide for a better stewardship of resources;
 and,
- 4) to provide for the optimum use of clergy and lay personnel.

Accordingly, having judged that sufficient just causes are present and that the good of souls will not thereby be impaired, and having consulted the Council of Priests in accord with canon 515, §2, I hereby **DECREE** an extinctive union by which Saint Ann Parish, Bristol, Pennsylvania will be merged into Saint Mark Parish, Bristol, Pennsylvania. Saint Mark Church will continue to serve as the parish church.

The intention or will of donors, as well as any acquired rights, have been examined and taken into consideration, especially regarding the allocation of goods and the obligation of debts. The goods of Saint Ann Parish, including their property and treasury, as well as any debts, are assigned to Saint Mark Parish.

The rich legacy and history of Saint Ann Parish are to be promoted and honored. Saint Ann Church will remain open for worship as a part of Saint Mark Parish. Saint Mark Parish will provide for the pastoral care of the Italian speaking people of the area. The sacramental registers of Saint Ann Parish shall be preserved at Saint Mark Rectory.

This decree becomes effective as of July 1, 2014, prior to which it is to be communicated to the parishioners and to the Faithful of the Archdiocese in an appropriate manner. All things to the contrary notwithstanding.

Our Lady of Fatima Parish, Bensalem, Pennsylvania was founded in 1954. Saint Charles Borromeo Parish, Bensalem, Pennsylvania was founded in 1903. As the result of an Archdiocesan Pastoral Planning initiative, a proposal to merge Our Lady of Fatima Parish into the neighboring Saint Charles Borromeo Parish was studied and discussed with committees from both of the parishes and with the appropriate archdiocesan offices. The boundaries of Saint Charles Borromeo Parish are hereby altered to the following:

Bristol Rd. from Rt. 1 to Galloway Rd.; to Knights Rd.; to Street Rd. (extended); to Delaware River; to Poquessing Creek; to Rt. 1; to Bristol Rd.

The intention or will of donors, as well as any acquired rights, have been examined and taken into consideration, especially regarding the allocation of goods and the obligation of debts. The goods of Our Lady of Fatima Parish, including their property and treasury, as well as any debts, are assigned to Saint Charles Borromeo Parish.

The rich legacy and history of Our Lady of Fatima Parish are to be promoted and honored. Our Lady of Fatima Church will remain open for worship as a part of Saint Charles Borromeo Parish. The sacramental registers of Our Lady of Fatima Parish shall be preserved at Saint Charles Borromeo Rectory.

I-95; to Neshaminy Creek; to New Falls Rd.; to Durham Rd.

The intention or will of donors, as well as any acquired rights, have been examined and taken into consideration, especially regarding the allocation of goods and the obligation of debts. The goods of Immaculate Conception B.V.M. Parish, including their property and treasury, as well as any debts, are assigned to Queen of the Universe Parish.

The goods of Holy Spirit Parish, including their property and treasury, as well as any debts, are assigned to Saint George Parish.

The rich legacy and history of Holy Spirit Parish are to be promoted and honored. Holy Spirit Church will remain open for worship as a part of Saint George Parish. The sacramental registers of Holy Spirit Parish shall be preserved at Saint George Rectory.



SAINT AUGUSTINE PARISH, BRIDGEPORT, PENNSYLVANIA, OUR LADY OF MOUNT CARMEL PARISH, BRIDGEPORT, PENNSYLVANIA

AND

SACRED HEART PARISH, SWEDESBURG, PENNSYLVANIA

Saint Augustine Parish, Bridgeport, Pennsylvania was founded in 1892. Our Lady of Mount Carmel Parish, Bridgeport, Pennsylvania was founded in 1924 to serve Italian speaking people in the area. Sacred Heart Parish, Swedesburg, Pennsylvania was founded in 1907 to serve Polish speaking people in the area. As the result of an Archdiocesan Pastoral Planning initiative, a proposal to merge these three parishes together to form one new parish was studied and discussed with committees from all of the area parishes and with the appropriate archdiocesan offices. Throughout this process, sufficient information regarding the proposal was gathered, and consultation was conducted with members of Saint Augustine Parish, Our Lady of Mount Carmel Parish, and Sacred Heart Parish.

The following just causes suggest that Saint Augustine Parish, Our Lady of Mount Carmel Parish and Sacred Heart Parish be merged into one parish:

- to provide more effectively for the pastoral needs of the faithful of all three parishes which have declined in population in recent years.
- Our lady of Mount Carmel Parish no longer serves a predominately Italian speaking community and Sacred Heart Parish no longer serves a predominately Polish speaking community;
- to enhance evangelization efforts and to improve the vitality of parish life for the people of all three Parishes;







Accordingly, having judged that sufficient just causes are present and that the good of souls will not thereby be impaired, and having consulted the Council of Priests in accord with canon 515, §2, I hereby **DECREE** an extinctive union by which Holy Spirit Parish, Philadelphia, Pennsylvania will be merged into Saint Richard Parish, Philadelphia, Pennsylvania. Saint Richard Church will continue to serve as the parish church.

The boundaries of Saint Richard Parish are hereby altered to the following:

Broad St. from Oregon Ave. to League Island Blvd.; then air line to Patrol Rd; then air line to Delaware River; to Schuylkill River; then air line to Oregon Ave.; to Broad St.

The intention or will of donors, as well as any acquired rights, have been examined and taken into consideration, especially regarding the allocation of goods and the obligation of debts. The goods of Holy Spirit Parish, including their property and treasury, as well as any debts, are assigned to Saint Richard Parish.

The rich legacy and history of Holy Spirit Parish are to be promoted and honored. Holy Spirit Church will remain open for worship as a part of Saint Richard Parish. The sacramental registers of Holy Spirit Parish shall be preserved at Saint Richard Rectory.

This decree becomes effective as of July 1, 2014, prior to which it is to be communicated to the parishioners and to the Faithful of the Archdiocese in an appropriate manner. All things to the contrary notwithstanding.



DECREE

OF THE RELEGATION OF

OUR LADY OF THE BLESSED SACRAMENT CHURCH, PHILADELPHIA, PENNSYLVANIA

TO PROFANE BUT NOT SORDID USE

Due to the high cost of repairing and maintaining Our Lady of the Blessed Sacrament Church, Philadelphia and due to a lack of the funding necessary to cover the expenses of the church, consideration must be given as to whether sufficient grave causes exist for the relegation of Our Lady of the Blessed Sacrament Church to profane but not sordid use.

The following grave causes suggest that the church be so relegated and no longer be used for divine worship:

- Our Lady of the Blessed Sacrament Church has been costing Saint Cyprian Parish approximately \$35,000 a year just to maintain. In addition, the church building continues to have problems that necessitate expensive repairs, such as a recent expense of \$3500 to repair water damage from a broken pipe;
- Saint Cyprian Parish, Philadelphia, which has ownership of Our Lady of the Blessed Sacrament Church, does not have the resources to repair and to continue to maintain the Our Lady of the Blessed Sacrament Church building. The parish has a debt and has difficulty in meeting its operating expenses;
- 3) there is no other source of funding for the church maintenance and necessary repairs;
- the financial burden of repairing and maintaining Our Lady of the Blessed Sacrament Church would cause staffing and important pastoral programs of Saint Cyprian Parish, such as outreach to the poor and educational efforts, to suffer due to lack of funds;

- Our Lady of the Blessed Sacrament Church building does not have any particular architectural, historical, or artistic significance; and,
- 6) the people who had been attending Our Lady of the Blessed Sacrament Church are in reasonably close proximity to Saint Cyprian Church, so the relegation of Our Lady of the Blessed Sacrament Church would not deprive anyone of the use of a church.

Accordingly, in virtue of the prescripts of canon 1212 and canon 1222, §2 of the <u>Code of Canon Law</u>, having judged that sufficient grave causes are present and that the good of souls will not thereby be impaired, having consulted with the Pastor of Saint Cyprian Parish and having consulted with the Council of Priests, I hereby **DECREE** that Our Lady of the Blessed Sacrament Church, Philadelphia, Pennsylvania, be relegated to profane but not sordid use.

This decree is effective as of August 1, 2014, and is to be communicated to the members of Saint Cyprian Parish and to the faithful of the Archdiocese in an appropriate manner. All things to the contrary notwithstanding.

DECREE

OF THE RELEGATION OF

SAINT CALLISTUS CHURCH, PHILADELPHIA, PENNSYLVANIA

TO PROFANE BUT NOT SORDID USE

Due to the deteriorating condition of Saint Callistus Church, Philadelphia and a lack of the funding necessary to repair and maintain the church, consideration must be given as to whether sufficient grave causes exist for the relegation of Saint Callistus Church to profane but not sordid use.

The following grave causes suggest that the church be so relegated and no longer be used for divine worship:

- Saint Callistus Church has been examined by experts who have found that the church building has a serious environmental problem with mold. The presence of mold makes the use of the a health hazard. Professional estimates on the costs of removing the mold and making the repairs necessary to the church roof and foundation so as to avoid a reoccurrence of the problem run between a minimum of approximately \$260,000 to a maximum of approximately \$345,000. This is over and above the annual costs of other repairs, insurance, and maintenance of the church.
- Our Lady of Lourdes Parish, Philadelphia, which has ownership of Saint Callistus Church, does not have the resources to repair and maintain the Saint Callistus Church building. The parish already has an outstanding debt of approximately \$429,000 and has been unable to meet its annual operating expenses;
- 3) there is no other source of funding for the necessary repairs;
- 4) the financial burden of repairing and maintaining the church would cause important pastoral programs of Our Lady of Lourdes Parish, such as outreach to the poor and educational efforts, to suffer due to lack of funds;

- 5) the church building does not have any special architectural, historical, or artistic significance; and,
- 6) the people who had been attending Saint Callistus Church are in reasonably close proximity to Our Lady of Lourdes Church.

Accordingly, in virtue of the prescripts of canon 1222, §2 of the <u>Code of Canon Law</u>, having judged that sufficient grave causes are present and that the good of souls will not thereby be impaired, having consulted with the Pastor of Our Lady of Lourdes Parish, and having consulted with the Council of Priests on September 12, 2014, I hereby **DECREE** that Saint Callistus Church, Philadelphia, Pennsylvania, be relegated to profane but not sordid use.

This decree is effective as of October 1, 2014, and is to be communicated to the members of Holy Name of Jesus Parish and to the faithful of the Archdiocese in an appropriate manner. All things to the contrary notwithstanding.

DECREE

OF THE RELEGATION OF

SAINT LAURENTIUS CHURCH, PHILADELPHIA, PENNSYLVANIA

TO PROFANE BUT NOT SORDID USE

Due to the deteriorating condition of Saint Laurentius Church, Philadelphia and a lack of the funding necessary to repair and maintain the church, consideration must be given as to whether sufficient grave causes exist for the relegation of Saint Laurentius Church to profane but not sordid use.

The following grave causes suggest that the church be so relegated and no longer be used for divine worship:

- Saint Laurentius Church has been examined by experts who have determined that the building is unsafe for use and in need of extensive repairs. On March 19, 2014 the City of Philadelphia declared the building is "unsafe" and ordered that either repairs be made or the building be demolished. Engineers hired by Holy Name of Jesus Parish, which has ownership of the church, found Saint Laurentius Church "a potential safety hazard to the public."

 In summary there are numerous cracks in the facade of the building and the church's towers are in danger of collapsing. The least expensive option, which itself would cost \$1 million, is to demolish the entire church. Merely stabilizing or repairing the church would cost anywhere between \$1.2 and \$3.4 million. Aside from the needed repairs, the costs of utilities, insurance, and maintenance for the church are approximately \$68,000 annually.
- 2) Holy Name of Jesus Parish, Philadelphia, which has ownership of Saint Laurentius Church, does not have the resources to repair and maintain the Saint Laurentius Church building. The parish already has a debt of approximately \$475,000 and has been unable to meet annual operating expenses;
- 3) there is no other source of funding for the necessary repairs;

- 4) the financial burden of repairing and maintaining the church would cause important pastoral programs of Holy Name of Jesus Parish, such as outreach to the poor and educational efforts, to suffer due to lack of funds;
- 5) the church building does not have any special architectural, historical, or artistic significance; and,
- 6) the people who had been attending Saint Laurentius Church are in reasonably close proximity to Holy Name of Jesus Church.

Accordingly, in virtue of the prescripts of canon 1222, §2 of the <u>Code of Canon Law</u>, having judged that sufficient grave causes are present and that the good of souls will not thereby be impaired, having consulted with the Pastor of Saint Holy Name of Jesus Parish, and having consulted with the Council of Priests on September 12, 2014, I hereby **DECREE** that Saint Laurentius Church, Philadelphia, Pennsylvania, be relegated to profane but not sordid use.

This decree is effective as of October 1, 2014, and is to be communicated to the members of Holy Name of Jesus Parish and to the faithful of the Archdiocese in an appropriate manner. All things to the contrary notwithstanding.
